### Business Support

CCBT operates a state-of-the-art business operation that collects around 85% of insurance payments within 30 to 45 days of your submission of a billing charge. The billing is done electronically, so there can be no doubt of its transmission or receipt. We also run statements several times per month to keep your patients up to date in their payment of their portion of their financial responsibility.

CCBT also keeps your risk well managed by providing standard forms to obtain consent and business agreements from patients, as well as obtain HIPAA policy acknowledgement. Further, you will be given standard note forms, that include both psychotherapy notes and protected health information records. We also use standard intake schedules, written interview forms, and provide termination summaries and treatment planning forms. Billing is done on a superbill so you can be sure that your billing records are consistent with your clinical notes. We have a form for almost everything.

Insurance authorizations are obtained at intake by the administrative staff. Intake calls are processed the same way, so you only have to worry about clinical work when you see the patient the first time. We use an online computerized calendar so your appointments can be booked by our staff, or if you prefer, by you.

Credentialing is supported by our administrative staff. We manage your NPI number and your CAQH files, as well as work to keep you on insurance panels, or add you to new ones. We also have several group contracts that can afford an expedited credentialing for some providers.

### Group Contracts

An advantage to joining CCBT is that we have contracts with all major carriers in Ohio. While credentialing requirements for managed care panels vary depending on the carrier, our contracts allow us to expedite your credentialing. You should be able to access a wider array of referrals and increase your caseload more quickly under our group contracts than you could at most other offices.

### Clinical Support

The multi-disciplinary staff of 20+ clinicians affords opportunity to discuss cases throughout the day. You don't need to ever feel isolated at CCBT.

### Continuing Education

You receive free CE. We operate a semi-monthly CE program, and strive to be approved by most licensing boards. Presently, we are approved by the Ohio Psychological Association to offer MCE for psychologist, and by the Ohio Counselor and Social Work Board to offer CEs to PCCs and LISWs. You simply show up and take the training, and CCBT keeps you from being burdened by the cost of CE.

### Independent Contractor Status

As a licensed professional, you are treated as an independent practitioner, and your affiliation with CCBT is that of an independent contractor. Your patients are your patients, and CCBT does not direct your clinical work. You apply the tools of your clinical skills and CCBT provides you with services and space to do so.

### Reasonable Cost-Share Rate

The rates CCBT keeps for its costs of supporting you are typically below the average for similar full-service practice service organizations.

### Leadership

CCBT tries to stay ahead of the rest by making sure you have access to research and opportunities to excel.
